#### In Town

**One Day**      **\$8,000 to be received 3 weeks in advance**

**If traveling out of the City of Los Angeles is required, any time requested for travel over and above 1 hour, will be at the hourly rate (not included are night flights or after hour flights) plus travel expenses to include: Airfare (if over 1 hour, flight needs to be business class), hotel, transportation (car rentals or mileage), and meals (Airfare and hotel are to be paid in advance). If a day out of the office is spent examining patients, compensation is for the time spent out of the office to examine the patients at the daily fee of \$8,000.00 and does not include the charges for reports, record review or literature research.**
